RESOLUTION NO. 2024-062

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA

FORMING THE SHASTA COUNTY PERMANENT ROAD DIVISION AND CONVERTING ALL ACTIVE PERMANENT ROAD DIVISIONS INTO ZONES UNDER THE SHASTA COUNTY PERMANENT ROAD DIVISION

WHEREAS, California Street and Highways Code Division 2, Chapter 4, Article 3, also known as the Permanent Road Division Law, sets forth the rules and provisions for establishing and maintaining Permanent Road Divisions (PRDs); and

WHEREAS, there are 92 active PRDs within Shasta County, as shown in the Existing Active PRD Table, attached hereto as Exhibit A, and incorporated herein; and

WHEREAS, Section 1162.6 of the Permanent Road Division Law allows for the creation of a single PRD that encompasses the entire unincorporated area of the County; and

WHEREAS, Section 1162.6 of the Permanent Road Division Law allows for the creation of zones within a countywide PRD for specific permanent road projects, with differing special taxes or parcel charges; and

WHEREAS, on the 17th day of June, 2024, the Board of Supervisors, recognizing that creating a single PRD that encompasses the entire unincorporated area of the County and converting all active PRDs into zones within the single countywide PRD will promote more efficient operations and stewardship of public funds, passed Resolution No. 2024-054, initiating the formation of the Shasta County PRD and establishing the date and time for a public hearing; and

WHEREAS, on this 25th day of June, 2024, a public hearing was held regarding the formation of the Shasta County PRD.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Shasta declares the Shasta County PRD to be formed encompassing the entire unincorporated area of the County of Shasta and that all active PRDs, as referenced in Exhibit A, shall become individual PRD Zones within the Shasta County PRD, each retaining their previously approved boundary and assessment.

BE IT FURTHER RESOLVED that all future PRDs will be created as zones within the Shasta County PRD in accordance with Permanent Road Division Law.
