**Agricultural Commissioner/  
Weights & Measures**



Land assessment/values; parcel/land ownership; maintain index of vital records for birth, death, and marriage certificates.

**Assessor-Recorder**



Chief Financial Officer for Shasta County. Responsible for broad range of accounting and payroll duties.

**Auditor-Controller**



Includes Shasta County CEO. Oversight and administration for Shasta County Departments. Clerks to Board of Supervisors.

Office/Clerk of the Board**



Processes marriage licenses, passport application, fictitious business name. Maintains and updates voter records. Conducts elections.

**County Clerk/  
Registrar of Voters**



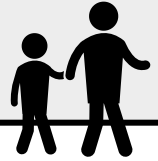
Attorney for Shasta County departments. Legal advice; contract review; additional legal services as needed for county departments.

**County Counsel**



Volunteer fire protection in area's not covered by incorporated cities or fire districts. Contracted with CAL FIRE.

**County Fire**



Establishes paternity; locates absent parents; establishes child and medical support orders; collects and distributes support monies.

**Child Support Services**



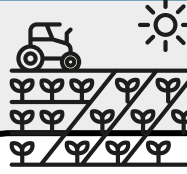
Charges and prosecutes criminal violations on behalf of the people of the State of California. Provides services to victim of crimes.

**District Attorney**



Provides essential services to residents of Shasta County. Economic Mobility, Public Health, Behavioral Health and Social Services, & Housing,

Services Agency**



University of California extension service. Conducts research in agriculture, natural resources, nutrition, & youth development.

**Farm Advisor**



Internal service department. Provides computer technology support to all Shasta County departments. Software/web. Telecommunications.

**Information Technology**



Provides safety through supervision of convicted and adjudicated adults and juvenile offenders for Shasta County

**Probation**



Provides legal representation for persons unable to afford counsel in certain cases where life or liberty are at stake.

**Public Defender**



Builds and maintains County roads, buildings, airports, and other facilities. Maintains County buildings. Administers solid waste, transit, and fleet.

**Public Works**



Responsible for building permits, land development, environmental health, air quality, food services inspection, hazardous waste.

**Resource Management**



Responsible for law enforcement services in unincorporated areas of Shasta County, including the Shasta County Jail.

**Sheriff-Coroner**



Human resources & purchasing for County departments, Risk Management promotes safety and wellness for Shasta County workforce.

**Support Services**



Manages investments of the County. Collects property tax revenue. Responsible for distribution of estates where no other executor.

**Treasurer/Tax Collector/  
Public Administrator**



Shasta County's advocate for all veterans and their families, Outreach and counseling for veterans and eligible dependents.
